# 1. - Collection and use of personal data

## a) Personal data provided

You may choose whether or not to provide us with your personal information including but not limited to the following information, name, address, telephone number, or e-mail address, among others, through our website or web portal. If you choose not to provide us with your personal information, you may not have access to some of the services we offer on our site or web portal. Here's how to provide your personal information, what kind of personal information you need to enter and how we use it.

#### Contact

## b) Automatic compilation of personal data

By visiting this site or web portal, we automatically collect some personal data, which we then add to a set so that they are not associated with a single person that is identifiable.
